### News from GP-TCM RA members:

**1. Professor De-an Guo, President-Elect of the GP-TCM RA, was honoured with a prestigious National Award:** On 18<sup>th</sup> Jan. 2013, Professor De-an Guo received a National Natural Science Award (Second Grade) in the People's Hall in Beijing, China. Thirteen State Leaders including Jin-ping Xi (Party General-Secretary), Jin-tao Hu (President) and Jia-bao Wen (Premier) issued the award to awardees or their representatives. This is the first National Natural Science Award in TCM field. The GP-TCM RA would like to call on all members to congratulate De-an on his award. **Warmest congratulations, De-an!**

De-an's award will prove to be a huge inspiration for all GP-TCM RA members and will encourage lots of young people joining the field. Here is a brief introduction to the award:

*Systematic Analysis of Active Components in Complex System of Traditional Chinese Medicine and Its Application in Quality Standard - Primarily achieved by Guo De-An, Ye Min, Wu Wan-Ying, Guan Shu-Hong, Liu Xuan*

*Multiple approaches, including natural products chemistry, analytical chemistry, pharmacology and molecular biology, were employed to develop a series of novel methodologies for comprehensive analysis of traditional Chinese medicines. On the basis of these developments, a new model for the quality standards of TCMs was established and successfully adopted by Chinese Pharmacopoeia and United States Pharmacopoeia for the herbal standards.*

*This project was designed toward the multiple components and complex systematic analysis of traditional Chinese medicine, focusing on the commonly used Chinese herbs such as Dan-Shen (Chinese Salvia) and Ling-Zhi (Ganoderma lucidum). The project brings forward innovative ideas and techniques to establish the integrated "chemical analysis – in vivo metabolism – biological mechanism" methodology, which is applied to modern TCM research. A total of 89 papers resulting from this project have been published in SCI cited journals with Dr. Guo De-An as the corresponding author. The highest impact factor of individual paper reached 9.39. Twenty core papers have been cited for 605 times by other groups, and eight representative papers received 321 SCI citations by other groups.*

**2. New Year's MBE Honour to Chinese Herbs Expert Christine Leon:** Chris Leon of the *Chinese Medicinal Plants Authentication and Conservation Centre* of Royal Botanical Gardens Kew (RBGK)'s Jodrell Laboratory has been awarded an MBE (Member of the Most Excellent Order of the British Empire) in the New Year's Honours List for services to the UK-China Science Relationship. **Warmest congratulations, Chris!**

Chris has been working on the identification and safety of traditional herbal medicines since 1994. In 1998, she commenced an active field programme in China to collect plants and their medicinal parts as used in Traditional Chinese Medicine (TCM). This has taken her to 19 provinces in China where she has worked closely with different groups and fostered collaborations that have resulted in the creation of a vouchered collection of over 4,500 plant and fungal dried reference drugs including common herbal substitutes, adulterants and counterfeits. Housed at Kew, these authentic drugs are actively being used to help improve the safe and efficacious use of Chinese medicinal plants in the UK, to help set standards for their quality control and to promote their sustainable supply from China. Over the years Chris has also built up a network of colleagues across China to undertake related joint research and scientific exchange with a strong focus on TCM plant identification, naming and conservation. Chris says: *'I'm deeply honoured to receive this award but as always the work described is a team effort so I accept this award on behalf of my Kew colleagues that*

have been so supportive and with particular thanks for the expertise and friendship of my many Chinese colleagues, notably Professors LIN Yu-Lin, ZHANG Bengang, LI Bao Li and CHEN Shi-Lin at the Institute of Medicinal Plant Development, Beijing, and without whom this resource would never have materialised.”

MCMIA was established in 2000 as a non-profit organisation by a group of TCM business professionals, scientists and academics. The goal of the association is to foster the internationalisation of TCM through its modernisation, popularisation and the enhancement of the professionalism of the TCM industry. In pursuit of the above goal, MCMIA strives to establish 3 platforms in Hong Kong for TCM. They are a Trading Platform, an Information Platform and a Quality Assurance Platform. The former 2 platforms have already been successfully built in collaboration with the Hong Kong Trade Development Council by co-organising International Conference & Exhibition of the Modernisation of Chinese Medicine & Health Products (ICMCM); weekly column in local newspaper, Ta Kung Pao; and sharing forums with local and Chinese experts on regulatory and policy matters. The Quality Assurance Platform is being

developed with the help of domestic and international agencies. Each year, MCMIA organises ICMCM which assembles the world's experts to explore the development of TCM, to report on scientific and technological advances, to introduce new products and to update on the global regulatory changes. ICMCM is evolving to become an international focal point for the promotion and the modernisation of TCM.

With Vivian's leadership, GP-TCM RA looks forward to collaborations with the MCMIA.

### 4. Secretary-General Tai-Ping Fan promoted GP-TCM RA in Korea and beyond in December 2012.

At the invitation of the Korean Society of Pharmacognosy, Tai-Ping gave a Plenary Lecture *Frontiers in Strategic Alliance in Herbal Medicine R&D – a European Perspective* at its 43<sup>rd</sup> Annual Meeting. He featured GP-TCM RA activities and invited the participants to join the Association. This was followed by another lecture at “New Trends in Natural Products Research” Symposium at Natural Products Research Institute (NPRI) of Seoul National University, where he made good contacts with other speakers, including Prof. Kazuki Saito (*Discovery of novel genes in plant secondary metabolism by integrated omics approach*; RIKEN Plant Science Center, Japan) and Prof. Steven Swanson (*Pharmacology of novel anticancer compounds derived from diverse natural products*; University of Illinois at Chicago College of Pharmacy).



Prof. Yeong Shik Kim, a non-beneficiary member of the GP-TCM Consortium, also invited Tai-Ping to meet Prof. Jin-Ho Chung, Dean of College of Pharmacy, as well as senior NPRI staff Prof. Sang Kook Lee and Prof. Sunghyoun Park. In particular, Tai-Ping enjoyed discussing with young members of Laboratory for Biofunctional Natural Products about their vibrant research projects on (i) development of anti-inflammatory and anti-cancer substances from natural products, (ii) preparative separation of natural products by HSCCC, and (iii) development of anti-adipogenic natural products.

### The GP-TCM RA: Past Milestones and Future Directions

- In December 2011, Professor Yung-Chi Cheng, Chairman of the Consortium for Globalization of Chinese Medicine (CGCM) and Co-Chairman of the GP-TCM Advisory Board, was awarded the prestigious Cheung On Tak International Award for Outstanding Contribution to Chinese Medicine. He received his award in April 2013. Warmest congratulations!

- In January 2012, the GP-TCM RA BoD was elected; it met so far in two face-to-face meetings and six teleconferences to discuss issues of GP-TCM RA.
- In March, GP-TCM RA Secretary-General Tai-Ping Fan was invited by the AAAS journal Science to edit a TCM Special Issue, due for publication in Q3/Q4 2013.
- In April, the open-access GP-TCM Special Issue of Journal of Ethnopharmacology was published (Guest Editors: Qihe Xu and Rudolf Bauer). It contains 20 peer-reviewed publications covering all the major aspects we discussed in the past years; the GP-TCM Final Conference (Kerkrade, the Netherland) and GP-TCM Congress (Leiden, the Netherlands) were held successfully; the GP-TCM RA bylaws were approved; a series of Phoenix TV reports on GP-TCM and GP-TCM RA were broadcast in Europe and China:

- From May to November, nine UK GP-TCM participating institutions jointly proposed to the European Commission that TCM be given top priority in future EU-China collaborations under the Health Theme in Horizon 2020, a proposal endorsed by GP-TCM members in eight additional EU Member States and Associated Country, including Austria, Estonia, Germany, Ireland, Italy, Luxembourg, Romania and Norway, through their National Contact Points.

- In September, the request from the GP-TCM RA BoD for the new Association to succeed GP-TCM's CGCM membership was accepted in principle by CGCM and it was agreed that the 12th CGCM Annual Meeting and the 2nd GP-TCM RA Annual Meeting will be held jointly in Graz, Austria in 2013; three GP-TCM RA members were invited by the European Medicines Agency to speak at HMPC (The Committee on Herbal Medicinal Products) Assessors Training on non-European Traditional Medicines and it was accepted in principle that GP-TCM RA will serve as an Interested Party at HMPC.
- In October, the 1st GP-TCM RA Annual Meeting was successfully held on 20th October 2012 in Shanghai (organized by De-an Guo) as part of the 2012 Shanghai International Conference for TCM and Natural Medicine [<http://www.s-tcm.com/english.html>]; senior members of the GP-TCM RA organised the International Symposium on Standardisation and Cooperation of TCM convened by Vice Commissioner of the State Administration of TCM, Da-ning Li, GP-TCM Advisors Academician Boli Zhang and Dr. Xiaopin Wang in Beijing. The main achievements of the GP-TCM project and the objectives and visions of the GP-TCM RA were disseminated to key stakeholders in China and beyond.
- In November, the incomes of the GP-TCM RA surpassed £10,000 and the process for registering GP-TCM RA as a charity in the UK was officially initiated; the FP7 GP-TCM website was archived ([project.gp-tcm.org](http://project.gp-tcm.org)), with its activities carried on by the GP-TCM RA website ([www.gp-tcm.org](http://www.gp-tcm.org)).
- In December, the final four Reports of the FP7 GP-TCM project, including the 2nd Periodic Report, the Final Report to the Commission, the Final Report to the Public, as well as the GP-TCM Dissemination Report, were submitted (available from [qihe.xu@kcl.ac.uk](mailto:qihe.xu@kcl.ac.uk)) and the new online version of GP-TCM RA Newsletter was launched [<http://www.gptcm.org/2012/12/3514/>].

Future GP-TCM RA annual meetings are: University of Graz, Austria (30th August 2013); China Medical University, Taiwan (2014) and University of Mons, Belgium (2015). In addition, upon completion of membership registration, we will form interest groups dedicated to discussions and collaborations on different aspects of good practices in the R&D of TCM. More exciting initiatives will follow.

**3. Network Pharmacology and Traditional Chinese Medicine:** Traditional Chinese medicine (TCM), an age-old healthcare system derived from China, is a mainstream medicine in China and is also popular in many other parts of the world. Due to historic reasons, the scientific base of TCM awaits consolidation but emerging evidence has begun to illustrate TCM as an area of important medical rediscoveries. For example, the 2011 Lasker-DeBakey Clinical Medical Research Award was awarded to Youyou Tu for the discovery of Chinese herb-derived artemisinin, a drug for malaria that has saved millions of lives across the globe and the 7<sup>th</sup> Annual Szent-Györgyi Prize was awarded to Zhen-Yi Wang and Zhu Chen for their TCM research that led to the successful development of a new therapeutic approach to acute promyelocytic leukaemia. These award-winning projects were both conducted well before the human genome was decoded and when information technology was in infancy. What has TCM to offer in the post-genomic era and the Information Age? To address this important question, the GP-TCM project kicked in as the 1<sup>st</sup> EU-funded EU-China collaboration dedicated to applying emerging technologies to TCM research. Besides the consensus that omics and systems biology approaches will likely play major roles in addressing the complexity of TCM, more than half GP-TCM consortium members who responded to a consortium survey also cast votes of confidence in network pharmacology in TCM research. Then, what is network pharmacology? What is the state of the art of this technology in modern pharmacological and toxicological studies, and finally, what are its possible roles in TCM research?
